I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:05 a.m. by Dr. Richard Strebeck, Chair ("Chair") on Friday, January 11, 2019. The meeting was held in the Robert E. Lee Building, 239 North Lamar Street, Suite 402, Jackson, Mississippi 39201. A roll call of Board members was taken and a quorum was present.

II. Board Operations

A. <u>Election of Officers</u>

It was motioned by Sallis, seconded by Williams, and passed by majority to elect Strebeck as Chair of the LPC Board for a term of 2 years. The motion passed 3-0 with Strebeck abstaining. It was motioned by Etheridge, seconded by Strebeck, and passed by majority to elect Williams as Vice-Chair of the LPC Board for a term of 2 years. The motion passed 3-0 with Williams abstaining. It was motioned by Williams,

seconded by Etheridge, and passed by majority to elect Sallis as Secretary of the LPC Board for a term of 2 years. The motion passed 3-0 with Sallis abstaining.

B. Minutes Approval

It was motioned by Etheridge, seconded by Williams, and unanimously agreed that minutes of the Thursday, November 8, 2018 Regular Board meeting be approved as amended. It was motioned by Etheridge, seconded by Sallis, and unanimously agreed that the minutes of the Friday, November 9, 2018, Regular Board Meeting be approved as amended. It was motioned by Etheridge, seconded by Williams, and unanimously agreed that the minutes of the Monday, November 26, 2018, Special Called Zoom Board meeting with NBCC to discuss the Jurisprudence Exam be approved. It was motioned by Etheridge, seconded by Sallis, and unanimously agreed that the minutes of the Wednesday, December 26, 2018, Emergency Called Teleconference Board meeting for the purpose of discussion of a Complaint be approved.

II. Financial Matters

A. Travel Vouchers

It was motioned by Sallis, seconded by Williams, and unanimously agreed to accept and pay travel expenses as requested for the month of January.

B. <u>Financial Report</u>

Gorman presented the LPC Board's *FY19 Year-to-Date Expenditures and Encumbrances to Budget Report*, dated January 9, 2019. Based on a recommendation from Gorman, it was motioned by Etheridge, seconded by Sallis, and unanimously agreed to accept the financial report presented by Gorman and to include all interagency fees as routine expenses in the financial policy to begin in February 2019.

Gorman informed the Board that the mileage rate increased to .58 and a new Trip Optimizer is available which reflects the changes.

The Board discussed requesting a 5% salary increase for the Executive Director; a Contractual Part-Time employee; contract for archiving and shredding files; and an increase in travel expenses.

It was motioned by Strebeck, seconded by Williams, and unanimously agreed that the Board exit the regular session and enter Executive Session. The Board entered Executive Session at 1:52 p.m.
