I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:05 a.m. by Dr. Walter Frazier, Chair ("Chair"), on Wednesday, July 27, 2016. The meeting was held at the Board office, located in the Robert E. Lee Building, 239 North Lamar Street, Suite 402, Jackson, Mississippi 39201. A roll call of members was taken and a quorum was present.

Introductions and Welcome to New Board Members

The Chair welcomed new Board members and asked for introductions. All present introduced themselves. The two new Board members are: Dr. Aretha Hargrove-Edwards and Steven Rollins Stafford.

Attorney Wm. Jeffrey Jernigan administered the Oath of Office to the new Board members and provided a short orientation.

Upon motion by Stafford, seconded by McCormick, the Board unanimously agreed Hargrove-Edwards serve as Board Secretary effective immediately.

II. Board Operations

A. Minutes Approval

Upon motion by McCormick, seconded by Frazier, the Board unanimously agreed to accept minutes of the Wednesday, June 15, 2016, Board meeting as written.

B. Financial Matters

1. Payment of Routine Expenditures

No routine expenditures were submitted for payment by Cornerstone Consulting, Inc.

2. FY2017 Budget Update

Upon motion by Stafford, seconded by McCormick, the Board unanimously agreed to accept the proposed budget request presented by Gorman, with amendments. The budget request is for fiscal year July 1, 2017-June 30, 2018.

3. Travel Vouchers

Upon motion by Stafford, seconded by McCormick, the Board unanimously agreed to pay travel vouchers totaling \$311.04.

III. Executive Session

It was motioned by Stafford, seconded by Hargrove-Edwards, and unanimously carried that the Board close the regular meeting at 10:23 a.m. to consider the necessity of an Executive Session. The Board determined that an Executive Session was needed to review licensure applications, renewals, and complaints and to discuss issues pertaining to matters of potential litigation. It was motioned by Stafford, seconded by McCormick, and unanimously carried that the Board had reason to go into Executive Session.

The Board exited closed session, upon motion by Stafford, seconded by McCormick, and unanimously carried. Upon motion by Stafford, seconded by McCormick, the Board unanimously agreed to go into Executive Session at 10:23 a.m.

The Chair recessed the Executive Session at 12:09 p.m.

The Chair reconvened the Executive Session at 12:49 p.m.

Upon conclusion of the business of the Executive Session, motion by Stafford, seconded by Hargrove-Edwards, and unanimously approved, the Board agreed to exit Executive Session, and return to open session at 4:19 p.m.

Upon return to open session, the following was announced as action taken while in Executive Session. Complaints were reviewed and discussed. Requests for informal hearings were discussed and hearing dates set. LPC and LPC-S Applications were reviewed. Certificates were signed.

It was motioned by Stafford and seconded by Frazier to accept a recommendation from McCormick to take no action on Complaint 2015-10. Ayes – 3; Nays – 0; Abstention – 1 (McCormick).

It was motioned by McCormick, seconded by Stafford, and unanimously carried to accept a recommendation from Dr. Glenn Waller (former Board member) to set a hearing for Complaint 2015-11.1 and Complaint 2015-11.2.

It was motioned by Stafford and seconded by McCormick to accept a recommendation from Frazier to take no action on Complaint 2015-18. Ayes – 3; Nays – 0; Abstention – 1 (Frazier).

It was motioned by Stafford and seconded by Frazier to accept a recommendation from McCormick to take no action on Complaint 2015-21. Ayes – 3; Nays – 0; Abstention – 1 (McCormick).

It was motioned by Stafford and seconded by Frazier to accept a recommendation from McCormick to take no action on Complaint 2015-20. Ayes – 3; Nays – 0; Abstention – 1 (McCormick).

It was motioned by Stafford and seconded by McCormick to accept a recommendation from Frazier to take no action on Complaint 2015-23, Complaint 2015-24, Complaint 2015-25, and Complaint 2015-27. Ayes – 3; Nays – 0; Abstention – 1 (Frazier).

It was motioned by Stafford, seconded by Frazier, and unanimously carried to take no action on Complaint 2016-01.

It was motioned by Stafford and seconded by Hargrove-Edwards to accept a recommendation from Frazier to set a date for an administrative hearing for Complaint 2016-04 and 2016-05. Ayes – 3; Nays – 0; Abstention – 1 (Frazier).

It was motioned by Stafford, seconded by Hargrove-Edwards, and unanimously carried that the Board accept the Application Review as presented by the Executive Director.

It was motioned by Stafford, seconded by McCormick, and unanimously carried that the Board exit the Executive Session at 4:19 p.m. and return to open session.
