I. Call to Order

A determination vote for an Executive Session may be called at any time during the meeting.

II. Board Operations

A. Minutes

- a. November 1, 2019 meeting minutes were approved as submitted.
- b. November 6-8, 2019 Mr. Stafford motioned to adopt the meeting minutes as amended, second by Dr. Sallis. Vote: 3-0-1 (Dr. Etheridge abstained)
- c. November 19, 2019 meeting minutes were approved as submitted.
- d. November 22, 2019 meeting minutes were approved as submitted.

III. Financial

- A. Motion to approve travel for the meeting was made by Stafford, seconded by Dr. Sallis. Approved 3-0-1 (Dr. Etheridge recused herself).
- B. The Board reviewed the Cornerstone Consulting Invoice. No motion was needed because this invoice is a routine expense for accounting services
- C. Received update on ProsonITech invoice.
- D. Mr. Stafford motioned to replace office computers at a cost of no more than \$1200 each, seconded by Dr. Sallis. Approved 3-0-1 (Dr. Etheridge recused herself).
- E. The Board reviewed the FY 21 budget request. The primary difference is requesting an Administrative Assistance IV for Ms. Mordecai, which would facilitate office procedures and responding to licensee and constituent needs.

IV. Old Business

- A. The Board reviewed the Jurisprudence exam and made revisions. Ms. Mordecai will forward corrections to NBCC with a July 1, 2020 implementation date.

II. Agreed Order – David Carpenter (2018-48)

Dr. Sallis updated the Board regarding the Agreed Order for David Carpenter (2018-48). After hearing from Dr. Sallis, Mr. Carpenter, and Mr. Bain, Mr. Stafford motioned to acknowledge that Mr. Carpenter has not completed any aspect of the Agreed Order, Dr. Etheridge seconded the motion. Approved 3-0-1 (Dr. Sallis recused herself).

Upon exiting the Executive Session at 10:26 a.m., the Board announced that Mr. Carpenter's LPC License is suspended until the terms of Agreed Order 2018-48 is completed.

IV. Administrative Hearing for David Carpenter (2019-18)

The Board conducted the Administrative Hearing.

At 6:25 p.m., upon motion made by Mr. Stafford, with a second by Dr. Etheridge, the Board voted to go into a closed determination session to establish the need for an Executive Session. (Dr. Sallis recused herself).

In the determination session, moved by Mr. Stafford, seconded by Dr. Etheridge, that the Board had reason to go into Executive Session to deliberate regarding 2019-18.

In Executive Session: clear and convincing evidence was presented that Mr. Carpenter employed two (2) former clients at his counseling practice and knowingly allowed an unlicensed person to practice counseling. Mr. Stafford motioned (1) to suspend Mr. Carpenter's License for 12 months and (2) not allow Mr. Carpenter to apply as an LPC-S for 5 years. Vote: 3-0

At 6:31 p.m., the Board exited Executive Session and announced that Mr. Carpenter's license is suspended for 12 months, he cannot apply as a Board Qualified Supervisor for 5 years, and was assessed costs for the administrative hearing and investigation.
