Regular Board Meeting Tuesday, October 16, 2018

I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 8:06 a.m. by Dr. Richard Strebeck, Chair ("Chair") on Tuesday, October 16, 2018. The meeting was held in the Robert E. Lee Building, 239 North Lamar Street, Suite 402, Jackson, Mississippi 39201. A roll call of Board members was taken and a quorum was present. The meeting was continued from the October 15, 2018 meeting.

It was motioned by Stafford, seconded by Williams, and unanimously agreed to exit Executive Session and return to Regular Session. The Board returned to Regular Session at 8:07 a.m.

II. Old Business

A. Rules and Regulations for HB 708 – Update

B. MS Jurisprudence Exam

The Board will continue to work with NBCC regarding the Jurisprudence Exam. The Board was notified that if separate questions were added to an exam for only Board

Qualified Supervisors, it would delay the implementation of the exam by 2 months. It was motioned by Etheridge, seconded by Williams, and unanimously agreed to add the 5 additional questions to the exam. The Board discussed the content areas to address for the Board Qualified Supervisors. Strebeck will notify NBCC of the Board's decision and the content areas to add. The target dated for implementation is now January 2019.

C. MCA Presentation

The Board discussed the presentation for the Annual MCA Conference, scheduled for November 7-9, 2018 at the Gulf Coast Convention Center in Biloxi, Mississippi. The Board will present on November 9, 2018 at 8:00 a.m. The presenters for each area were determined.

D. Website Redesign

Board members reviewed work completed by ProsonlTech thus far. Stafford will work on organization of information and content to include on website.

E. Board Member User Information

Clarification on students taking the NCE without a conferred Master's Degree. It was motioned by Sallis, seconded by Etheridge, and unanimously agreed to amend the contract with NBCC to allow students to take the NCE prior to degree confirmation.
