Regular Meeting Thursday, November 7, 2024 Minutes

#### I. Call to Order

The Special Called Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 1:25 p.m. by Dr. Kim Sallis, Chair ("Chair") on Thursday, November 7, 2024. The meeting was held at The Whitehouse Hotel, 1230 Beach Blvd, Biloxi, MS 39530. A roll call of board members was made, and a quorum was held.

### II. Board Operations

- A. Dr. Windham motioned, seconded by Dr. Strebeck, to amend the agenda allowing Ms. Kirkland to make public comments to the Board. The motion passed with a vote of 5-0. Following the vote, she addressed the Board.
- B. After reviewing the September 9, 2024 minutes, Dr. Windham motioned, Dr. Bradley seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.
- C. After reviewing the September 26-27, 2024 minutes, Dr. Windham motioned, Dr. Bradley seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.
- D. After reviewing the October 14, 2024 minutes, Dr. Bradley motioned, Dr. Windham seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.
- E. Dr. Windham motioned, seconded by Dr. Bradley, to contract with ThoughtSpan Technologies, Inc. to develop and manage the Board's licensing management system. The motion carried with a vote of 5-0.

# III. Old Business

- A. Dr. Windham motioned, seconded by Dr. Strebeck seconded, that beginning July 1, 2025, CE Broker will be the only continuing education reporting system. The motion carried with a vote of 5-0.
- B. Dr. Strebeck motioned, seconded by Dr. Bradley, to add Rule 4.12 as follows:

# IV. New Business

- A. Dr. Sallis motioned, seconded by Dr. Strebeck, to strike Rule 4.4.A.5. The motion carried with a vote of 5-0.
- B. The Board discussed scheduling a Board meeting on April 3, 2025. Dr. Windham will submit a call for proposal for the Board to present at the Woodall Conference, April 4, 2025.
- C. The Board discussed offering licensees online training throughout the year. The Board will discuss the feasibility of this in the next regularly scheduled meeting. Partner with NBCC or CE Broker for Townhall meetings.

#### CLOSED DETERMINATION SESSION

- B. Dr. Sallis motioned, seconded by Ms. Bouldin, to deny request for extension for obtaining full LPC licensure from Ashley Doris Hall. The motion carried with a vote of 3-0-2. Drs. Bradley and Strebeck recused.
- C. Ms. Bouldin motioned, seconded by Dr. Windham, to schedule 2024-07 for a show cause hearing.
- D. Dr. Strebeck motioned, seconded by Dr. Windham, to schedule show cause hearing for LPCs that did not disclose information pertaining to background check on the renewal application
  - 1. Dr. Strebeck motioned, seconded by Ms. Bouldin, to schedule 2024-38 for a show cause hearing. The motion carried with a vote of 3-0-1. Dr. Bradley was not present for this vote. Dr. Sallis recused.
  - 2. Dr. Strebeck motioned, seconded by Ms. Bouldin, to schedule 2024-37 for a show cause hearing. The motion carried with a vote of 3-0-1. Dr. Bradley was not present for this vote.
  - 3. Dr. Strebeck motioned, seconded by Ms. Bouldin, to schedule 2024-39 for a show cause hearing. The motion carried with a vote of 3-0-1. Dr. Bradley was not present for this vote.
- E. Dr. Strebeck motioned, seconded by Dr. Windham, to take no action in the matter of 2024-17. The motion carried with a vote of 3-0-1. Dr. Bradley was not present for this vote.
- F. Dr. Strebeck motioned, seconded by Dr. Windham, to take no action in the matter of 2023-40. The motion carried with a vote of 3-0-1. Dr. Bradley was not present for this vote. Dr. Windham recused.
