#### I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:00 a.m. by Dr. Juawice McCormick, Chair ("Chair") on Thursday, February 23, 2017. The meeting was held in the Robert E. Lee Building, 239 North Lamar Street, Suite 402, Jackson, Mississippi 39201. A roll call of Board members was taken and a quorum was present.

#### **II. Board Operations**

#### A. Minutes Approval

It was motioned by Frazier, seconded by Stafford, and unanimously agreed that minutes of the November 30, 2016, meeting be approved as written.

It was motioned by Frazier, seconded by Stafford, and unanimously agreed that minutes of the January 25, 2017, Special Called Board meeting be approved as amended.

It was motioned by Frazier, seconded by Stafford, and unanimously agreed that minutes of the December 14, 2016, meeting be approved as written.

#### B. Financial Matters

#### 1. Outstanding Invoices for Payment

There were no outstanding invoices for payment.

#### 2. Payment of Routine Expenditures

There were no routine expenditures presented.

#### 3. Copier Machine Contract

A quote document from RICOH, dated February 21, 2017, for copier/technology service was reviewed. The current contract expires on March 19, 2017. It was motioned by Frazier, seconded by Stafford, and unanimously agreed to authorize the Executive Director to sign the new contract with RICOH, which begins on March 20, 2017.

#### 4. Travel Vouchers

It was motioned by Frazier, seconded by Stafford, and unanimously agreed that invoices for travel expenses be added to the agenda of the Special Called Board Meeting, scheduled for Friday, February 23, 2017.

#### **III. Old Business**

#### A. Rules and Regulations

#### 1. NBCC/CCE Proposal / Juris Prudence Exam

A proposal from NBCC/CCE was discussed. It was determined that the proposal does not meet LPC Board needs for the Juris Prudence Exam administration.

#### 2. Establish 2017 Board meeting Schedule

The 2017 Board meeting schedule was set through June 30, 2017. Meetings will be held on the fourth Wednesday of each month. Meeting dates beyond June will be discussed at a later time.

#### **IV. New Business**

#### 1. Executive Director Contract

The Executive Director's contract expires on March 18, 2017. It was motioned by Stafford, seconded by Frazier, and unanimously agreed to extend the Executive Director's contract through June 30, 2017.

#### 2. Accounting Services Contract

A discussion ensued regarding the Cornerstone Consulting representative's lack of attendance at Board meetings. It was motioned by Stafford, seconded by Frazier, and unanimously agreed that the Board publish a request for bids for accounting services.

#### 3. LPC Mailing List

Stafford discussed the need for the Mississippi Licensed Professional Counselor Association (MLPCA) to obtain directory information from the Board of all LPCs in the State. Frazier suggested that the Board seek legislative authority to establish that addresses of LPC be made available to MLPCA. The Board directed the Executive Director to make adjustments to the LPC Board website that would give LPC's an option as to whether or not they want their contact information published on the website. The Board anticipates that more LPCs will allow their contact information to be published following the next LPC renewal cycle.

#### 4. Annual MLPCA Conference

McCormick reported that she plans to attend the Annual MLPCA Conference on Saturday, May 20, 2017 at Mississippi College in Clinton, Mississippi. She intends to present a session entitled "What to Expect from a Supervisor".

#### V. Executive Session

It was motioned by Frazier, seconded by Stafford, and unanimously agreed to close the regular meeting for consideration of the necessity for an Executive Session. The Board made a determination that an Executive Session was needed for the purpose of reviewing applications, attorney communications, complaints, and requests for hearings. It was motioned by Frazier, seconded by Stafford, and unanimously agreed that the Board go into Executive Session. The Board entered into Executive Session at 11:17 a.m.

The Board recessed Executive Session for lunch at 12:12 p.m.

When the Board returned, it returned to open session for financial matters at 1:00 p.m.

#### **II. Board Operations (cont'd)**

#### A. Financial Matters

Alice Gorman joined the meeting at 1:00 p.m. and presented the FY17 Year-to-Date Expenditures and Encumbrances to Budget report, dated February 23, 2017. The report indicated that the Board has \$113,249.33 on hand.

It was motioned by Frazier, seconded by Stafford, and unanimously agreed to return to Executive Session for aforementioned reason.

The Board returned to Executive Session at 1:15 p.m. and resumed reviewing applications, attorney communications, complaints, and requests for hearings.

Upon conclusion of the business of the Executive Session, motion by Frazier, seconded by Stafford, and unanimously approved, the Board agreed to exit Executive Session, and return to open session at 5:16 p.m.

Upon return to open session, the following was announced as action taken while in Executive Session. Applications were reviewed. Complaints were reviewed and discussed. Requests for Hearings were reviewed. Attorney communications were reviewed and discussed.

The following was reported out.

#### A. Attorney Communications

#### Reciprocity Agreement

Attorney Jernigan stated that the Board does not have a Reciprocity Agreement with other states. Frazier suggested that the Board submit a request to LPC Boards in Louisiana and Tennessee to enter into a Reciprocity Agreement. It was motioned by Stafford, seconded by Frazier, and unanimously agreed that the discussion be tabled until the next meeting.

#### B. Complaints/Denied Applications

#### 2016-03

The Board renewed discussions from the Special Called Board Meeting from the Administrative Hearing held on January 25, 2017, regarding Complaint 2016-03. The Board returned the proposed order from the Hearing Officer with suggested changes. Jernigan and McCormick recused themselves from the discussion.

#### 2015-11.1 and 2015-11.2

Regarding Complaints 2015-11.1 and 2015-11.2, the Board determined the Licensee had met the requirements of the 2015-11.1 and 2015-11.2 Final Order. It was motioned by Frazier, seconded by Stafford, and unanimously agreed that the defendant's license be reinstated effective March 1, 2017.

#### 2016-27

Regarding Complaint 2016-27, it was motioned by McCormick, seconded by Stafford, and unanimously agreed to take no action.

#### 2016-29

Regarding Complaint 2016-29, it was motioned by Stafford, seconded by Hargrove-Edwards, and unanimously agreed to take no action.

#### C. Licensure Application Review

Following completion of application reviews, it was motioned by Frazier, seconded by Stafford, and unanimously agreed that the Board approve the decisions made regarding those applications, which includes abstentions.
