I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:00 a.m. by Dr. Kimberly Sallis, Chair ("Chair") on Friday, May 5, 2023. The Board meeting was held in the Board's office in the Robert E. Lee Building, 239 North Lamar Street, Suite 402, Jackson, Mississippi 39201. A roll call of Board members was taken, and a quorum was present.

II. Administrative Hearing 2022-28

The Board considered a Motion for Continuance from the licensee. After consideration, Dr. Strebeck motioned, seconded by Mr. Boose, to grant the continuance request and no further continuance will be offered. The motion carried with a vote of 5-0.

III. Administrative Hearing 2022-34

CLOSED DETERMINATION/EXECUTIVE SESSION

Upon motion at 9:20 a.m. made by Dr. Etheridge with a second by Mr. Boose, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a vote of 5-0.

In the determination session, Dr. Etheridge motioned, with a second by Mr. Boose, that the Board had reason to go into Executive Session [Mississippi Code Annotated §25-41-7 (b & d) and Mississippi Code Annotated §73-52-1 (1 & 2)]. The motion carried with a vote of 5-0.

The Board considered the letter of reprimand, Dr. Etheridge and Ms. Morris recused from the discussions. Dr. Strebeck motioned, Mr. Boose seconded, the following revisions be made, reduce the CEH requirements from 21 to 18, successfully complete the Pass/Fail Jurisprudence Exam, the LPC-S application will not be reviewed until the completion of these terms. The motion carried with a vote of 4-0-1.

At 9:44 a.m. Mr. Boose motioned, seconded by Dr. Windham, to exit the executive session. The motion carried with a vote of 5-0.

- A. Ms. DeRossette updated the Board regarding the financial report.
- B. Dr. Etheridge motioned, Mr. Boose seconded, to approve the travel for the meeting on May 5, 2023. The motion carried with a vote of 5-0.
- C. The Board reviewed the contract from ProsonITech for FY 2024. Dr. Strebeck motioned, Dr. Etheridge seconded, to approve the contract. The motion carried with a vote of 5-0.
- D. Ms. Mordecai reported that she secured a business cellphone for LPC Board use and will no longer use a personal cellphone.

V. <u>Board Operations</u>

- A. After reviewing and making corrections to the March 10, 2023 minutes, Mr. Boose motioned, Dr. Etheridge seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.
- B. After reviewing and making corrections to the March 31, 2023 minutes, Mr. Boose motioned, Dr. Strebeck seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.

VI. Old Business

- A. Mr. Boose and Dr. Sallis provided an update on the Board's presentation at the F. E. Woodall Conference.
- B. The Board discussed the No Fail Jurisprudence Exam. NBCC corrected all the changes and Board members completed internal testing. The updated exam was available May 1, 2023.
- C. The Board discussed the Pass/Fail Jurisprudence Exam.
- D. The Board discussed that a universal license is valid only in Mississippi. It does not allow for working under an interstate compact or reciprocity.

VII. New Business

A. The Board discussed potential topics to submit for the MCA Call for Programs.

B. The Board met with Paul and Michelle Godeaux regarding their "Revoked Status".

VIII. Executive Session

CLOSED DETERMINATION/EXECUTIVE SESSION

Upon motion at 1:21 p.m. made by Dr. Strebeck with a second by Dr. Etheridge, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a vote of 5-0.

In the determination session, Dr. Etheridge motioned, with a second by Mr. Boose, that the Board had reason to go into Executive Session [Mississippi Code Annotated §25-41-7 (b & d) and Mississippi Code Annotated §73-52-1 (1 & 2)]. The motion carried with a vote of 5-0.

The Board discussed the licensure status of both Paul and Michelle Godeaux. Dr. Etheridge motioned, seconded by Mr. Boose, that the Board deny their request to change their status, and that the Board issue a letter explaining the non-disciplinary license revocation status. The motion carried with a vote of 5-0.

Dr. Etheridge motioned, seconded by Dr. Windham, that the Board allow David Carpenter to submit information for license renewal because the Board acknowledges that he completed the requirements of the Board Order 2020-23. The motion carried with a vote of 4-0-1.

Dr. Etheridge motioned, seconded by Mr. Boose, to deny Ms. Lisa Denton's request. The motion carried with a vote of 5-0.

The Board reviewed Ms. Housley-Strickland's request. Dr. Windham motioned, seconded by Mr. Boose, to schedule a hearing according to Rule 5.2. The motion carried with a vote of 5-0.

The Board reviewed Ms. Brittany Lenoir's request. Dr. Sallis motioned, seconded by Dr. Etheridge, to deny her request to extend her P-LPC expiration deadline. The motion carried with a vote of 5-0.

The Board reviewed Ms. Lewis's request. Dr. Strebeck motioned, seconded by Dr. Etheridge, to request from both Ms. Lewis and Ms. Smith handwritten supervision documentation (including supervision logs, progress notes, and updated online logs) and an affidavit provided by the Board within 10 days of receiving this notification. The motion carried with a vote of 5-0.

The Board reviewed Ms. Walker's request. Dr. Strebeck motioned, seconded by Dr. Etheridge, to request additional information regarding her accommodation request. The motion carried with a vote of 5-0.
