The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 1:01 p.m. by Dr. Richard Strebeck, Chair ("Chair") on Friday, September 20, 2019. The meeting was held via Teleconference and the public could attend the meeting in the Robert E. Lee Building, 239 North Lamar Street, Suite 402, Jackson, Mississippi 39201. A roll call of Board members was taken and a quorum was present. A determination vote for an Executive Session may be called at any time during the meeting.

#### A. Vice Chair Election

Due to the resignation from the Board by Victoria Williams, Congressional District IV, effective August 27, 2019, the Board held an election for Vice Chair as Williams held this position. Sallis was named Vice Chair and Etheridge was named Secretary.
