I. Call to Order

The special called meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board"), held in Suite 402 of the Board office located at 239 N. The purpose of the special called meeting was to discuss and establish the Board's participation in the upcoming Mississippi Counseling Association ("MCA") Conference November 5-7, 2013.

II. MCA Conference

There was discussion regarding the Board's participation in the MCA Conference. The Board directed the Executive Director to prepare and forward a compilation of rule changes, as submitted by board members, prior to the board meeting on November 5, 2013. It was noted that board members are expected to review the rule changes in advance of the board meeting, be prepared to discuss in detail the proposed changes and to vote on the proposed changes during the November 5 board meeting. Each board member is asked to prepare a statement with respect to the BQS that he or she would like addressed during the Board presentation and bring it to the Board meeting on November 5. In addition to proposed rule changes, the Board will bullet, during its presentation, proposed changes to the

statutes governing LPCs (Chapter 30, Title 73 of the Mississippi Code of 1972 as amended).
